Background

Trade secrets are the most common form of innovative knowledge. Trade secrets are also essential for collaborative research and innovation within the EU and an attractive alternative to IPR for protecting non-technological innovation.

However, the protection of trade secrets within the EU is uneven and fragmented. This led the European Commission to prepare and submit a draft Directive on the protection of undisclosed know-how and business information (trade secrets) against their unlawful acquisition, use and disclosure in November 2013. This Directive is currently under negotiation with the EU Parliament and Council and is expected to be formally approved before the end of 2015.

The purpose of this Round Table organized by UNION-IP and AEDC is to debate and brainstorm trade secrets and the draft Directive proposed by the European Commission. To do so, we are delighted to have both a speaker from the Unit responsible for the preparation of the Directive within the DG for Growth and the judge in charge of the Commercial Court of Almería (Spain) to give us their views. Likewise, we have assembled a varied and multicultural panel of legal experts, who have agreed to share their thoughts and experiences with us on a topic that will become key in starting the 4th Industrial Revolution.
